



## Hospice of the Valleys Skydive Experience Terms and Conditions

### **Booking Terms and Conditions**

(In this section 'you/your' refers to the jumper)

1. By signing up you agree to raise the minimum amount of sponsorship £380.00
2. A £70.00 non-refundable deposit is required at the time of booking. This is in addition to the sponsorship amount.
3. Sponsorship must be raised by 2 weeks prior to jump date together with the sufficient evidence of this.
4. Where insufficient sponsorship has been raised, it is your responsibility to pay the difference to the amount of £380.00. You will NOT be able to jump if this amount has not been raised.
5. If buying as a GIFT VOUCHER, the full cost of the jump must be prepaid £395.00. This includes a non-refundable deposit of £70.00. That said, sponsorship can still be raised for the Hospice of the Valleys.
6. The GIFT VOUCHER is only valid for the Hospice of Valleys Skydive date.
7. Should the weather be unsuitable for jumping on the specified date, another date will be arranged.
8. A fee of £50 will be charged for any cancellations within 4 weeks of the jump date. A fee of £100 will be charged for any cancellations within 48 hours of the jump date.
9. Once you have signed up you automatically become bound by the terms and conditions by the Hospice, Skyline Promotions Ltd and Swansea Skydive Centre.
10. All bookings once received by the Hospice of the Valleys are then processed through Skyline Promotions Ltd with the relevant information shared with these parties to confirm booking and activity. ### **Medical Restrictions**

(In this section 'you/your' refers to the jumper)

For a tandem skydive you must be at least 16 years old. For all jumps you must weigh under 15 stone for male and 13 stone for female with your weight in proportion to your height. The principal medical restrictions for all jumps are diabetes, epilepsy, fits, recurrent blackouts, heart or lung disease, mental illness and some cases of asthma but if you are in any doubt please contact us for further information. All jumpers are required to sign a medical form before their jump declaring their fitness to take part - this will be sent to you upon receipt of your booking but is also available on request through Skyline Promotions. Those under the age of 18 will need the medical form signed by a parent or guardian; anyone with medical conditions listed on form 115A will need to have form 115B signed by their doctor. These will be provided to you by Skyline Promotions Ltd once booking has been confirmed. A copy for your viewing can be found on our website.

### **Insurance**

(In this section 'you/your' refers to the jumper)

On payment to the parachute centre of the fee for the training and the jump, all jumpers are covered by the British Parachute Association Liability Insurance Policy up to £5 million for liability to Third Parties. Please note that this does not cover the jumper or their dependants for personal injury including death. All jumpers are therefore strongly recommended to take out their own insurance cover for personal accident benefits to whatever level they consider appropriate. They can do this either in conjunction with their own insurance broker or they may take advantage of the cover

detailed on the Skyline Promotions Ltd website. If you wish to take advantage of this scheme, then please refer to the insurance page on Skyline Promotions Ltd for full details.
