



Hospice of the Valleys Cardiff Half Marathon Charity place – Terms and Conditions

For this event you pledge to raise a minimum of £200 (excluding gift aid or registration fees where applicable) in sponsorship money for Hospice of the Valleys, which should be received by Hospice of the Valleys within 2 weeks of the event. All funds raised through the event must be payable to Hospice of the Valleys in £ sterling. The objective is to enjoy the event whilst raising as much sponsorship as possible.

All participants:

You confirm that you are medically fit and that you participate in the event at your own risk. In making the decision to take part you are satisfied that this activity is suitable for you as an individual. Hospice of the Valleys cannot be held accountable for aggravation to illness or injury sustained due to participation in this event. You are recommended to seek advice from your medical practitioner prior to taking part in this event, and make provisions to ensure your safe participation.

You understand that it is your responsibility to read any terms and conditions and documentation issued by the race organisers and to comply with these.

The minimum age for Cardiff Half Marathon under the Hospice of the Valleys Charity Place is 18 years of age on the day of the event. If you are currently 17 years of age, you confirm that you have informed a parent or guardian that you have joined Team Hospice of the Valleys and are fundraising for this event.

You are fully responsible for your actions whilst attending the event. This includes the event centre and during the event itself. Hospice of the Valleys does not accept responsibility for your actions nor the consequences of such actions.

You accept that Hospice of the Valleys will not be liable for any loss, damage, action, claim, costs or expenses which may arise from your participation in this event.

You have provided Hospice of the Valleys information about you and consent to the Hospice using this data. You understand that it will be necessary for the Hospice to share the data with the race organisers in order to participate in this event.

We will keep your details on our database so we can provide you with the best possible support every time you contact us.

All participants, supporters and spectators, including friends and families who choose to attend the event confirm that they are happy for their names, video footage, photographs taken of them during the event to be used to publicise the event by Hospice of the Valleys for commercial and fundraising purposes including, but not limited to marketing material, television broadcasts, social media, advertising, publications, and other documents or mediums that may be made available to the public. You specifically waive any right to any compensation you may have for appearing in any of the photographs/film/video/electronic representations and/or sound recordings of you at the event. Photographs of children will not be used in this manner without express written consent; unless the images are incidental, for example, children's images at the starting line.

Should you, for whatever reason, not take your place, all sponsorship forms and monies collected should be forwarded to Hospice of the Valleys or returned to your sponsors.
