1. Sponsorship Requirements

- You pledge to raise a minimum of £150.00 in sponsorship (excluding Gift Aid and registration fees).
- 80% of the minimum sponsorship must be received two weeks before the event.
- The remaining balance must be paid within one month after the event.
- All funds raised must be paid to Hospice of the Valleys in £ sterling.
- The aim is to enjoy the event while raising as much sponsorship as possible.

2. Medical and Personal Responsibility

- You confirm that you are medically fit to take part and participate at your own risk.
- You are responsible for determining whether this activity is suitable for you.
- Hospice of the Valleys cannot be held liable for any illness or injury aggravated or sustained due to your participation.
- You are encouraged to seek medical advice before taking part.
- You must take appropriate steps to ensure your own safety during the event.

3. Compliance With Event Rules

- You are responsible for reading and complying with all terms, conditions, and documentation issued by the event organisers and associated parties.
- You are responsible for your own actions at all times, including at the event centre and during the activity.
- Hospice of the Valleys does not accept responsibility for your actions or the consequences of those actions.

4. Liability

- Hospice of the Valleys accepts no liability for any loss, damage, claim, costs, or expenses arising from your participation.
- Event registration fees are non-refundable under all circumstances.

5. Event Cancellation

- Hospice of the Valleys may cancel the event due to extreme weather conditions or Force Majeure.
 - In this case, your place will automatically transfer to the rescheduled event.

- If you cannot attend the new date, you may transfer your place to another participant after consulting with the Hospice.
 - No refunds will be issued.
 - If the event is cancelled by the organiser (Zip World), all entries will be moved to the new date.
 - No refunds will be issued.

6. Insurance

- Participation is at your own risk.
 - Insurance is provided for third-party claims arising from accidental damage caused by participants during the event.
 - This cover is void if you are deemed to have acted negligently.
 - No additional personal insurance is provided by the Hospice.
 - Participants are strongly advised to arrange their own personal insurance cover.

7. Data Protection

- Your data is managed in accordance with GDPR and the Data Protection Act (2018).
 - Hospice of the Valleys will only use your information for the purpose for which it was provided and will not sell or pass it to third parties.

 - You consent to the Hospice sharing necessary data with the event organisers to facilitate your participation.
 - Your details will be kept on our database to provide continued support and relevant event information.

8. Event Communications

- By entering the event, you agree to receive pre- and post-event communications (including email and SMS) containing event-related information.
